- ➔ **REGULAR SESSION:** June 26-Aug. 3: Fee: \$50 for 6 weeks (or see pay daily option below)
- ➔ **NEW THIS YEAR: 7<sup>th</sup> WEEK!** Aug. 7-10! Fee: \$39 to add this week (more info below).
- ➔ **MONDAY–THURSDAY** all weeks other than the week of July 4th. This week the program runs Wednesday-Friday: July 5, 6 & 7 (NO July 3 or 4)
- ➔ **TIME:** 9:00am-1:00pm - All weeks
- ➔ **FEE** for regular 6-week session: \$50 for 6 weeks inclusive (no registration fee) OR pay daily with a \$20 registration fee, and then pay \$3 daily.
- ➔ **FEE** for 7th week August 7-10: \$39. This week requires additional payment. To register for this week, please check appropriate box on enrollment form (next page).

***A min. of 50 participants is needed to run this week.***

*Why is this week separate? Our funding, subsidies and fees only cover costs for 6 weeks. We have had many requests for a 7<sup>th</sup> week so one has been added at the lowest possible price. Registration numbers are limited based on the number of available counselors. Join us for lots of favorite activities!*

Join us for supervised sports, games, crafts and lots of fun Monday-Thursday from 9am-1pm (Week of July 4th Wed.-Friday).

Children are encouraged to come with friends & to meet new friends too! Every day will have its own theme and craft along with playground favorites, such as tie-dye projects, gimp, arts and crafts. Sports are a big part of this program and will vary throughout the day. Sports



include soccer, dodgeball, kickball, tennis and more (divided by age when necessary). Zumba is on Wednesdays! On warmer days, we play water games. Special events include talent shows, karaoke, and water slides.

Our experienced staff is looking forward to meeting and greeting both new and returning children this summer!



**Please note:** We are centered under the pavilion at the Pond Street fields. Since there are no indoor facilities, this program may alter opening or closing times due to inclement weather. Although we try to stay open, if it is raining steadily and especially if there is thunder or lightening nearby, children must be picked up immediately.
